RENTAL GUIDELINES

Please Note: Because of our fiduciary relationship with the owner, if multiple applications are submitted before approval can be achieved, we are required to select the best application(s) for placement. Otherwise, applications will be processed on a "first come-first serve" basis.

- Our process of approving applicants is based on an overall review and thorough check of five main categories. (Rental History, Employment History, Credit History, Income and Criminal background).
- Proof of employment and three recent pay check stubs. Selfemployment must be verified with tax returns, 1099's and/or bank statements. Any variance to employment requirements must be approved by Property Manager and agreed to by applicant(s). Written verification of active military status and income must be provided.
- A gross monthly income of at least three times the monthly rent.
 Roommates should each qualify individually. Insufficient income may be denied. All forms of income must be provided.
- Proof of rental history or mortgage verification in writing.
- Acceptable credit history.
- Prior evictions may be automatically denied.
- Government issued identification card (Example- Driver's License, Military Identification, Passport, along with Social Security card when applicable. Copies must be provided.
- Everyone 18 or older must fill out a separate application and be on the lease UNLESS it is verified in writing said persons are full-time college students not living full-time at premises applied for.

All applicants must have a have a criminal background check and applicants who have a criminal background may be automatically denied. A nationwide eviction search is run for each applicant.

Please do not submit incomplete applications. Incomplete applications may be automatically denied.

\$50 application fee per adult person 18 or over and is non-refundable.

\$500 hold fee per application/refundable if not approved; applies toward security deposit if approved.
